**CO- RESPONSIBILITY AGREEMENT- COVID -19 ADDITIONAL PART**  
**NURSERY SCHOOL**  
**( INFANZIA)**

Co-responsibility agreement between the Comprehensive Institute UGO FOSCOLO, Vescovato and the families of the registered children about the organizational, health and hygiene measures and the correct individual behaviour in order to contain the spread of contagion of Covid-19.

SIGN THE FOLLOWING CO-RESPONSIBILITY AGREEMENT CONCERNING THE RULES TO FOLLOW IN ORDER TO CONTAIN THE SPREAD OF CONTAGION OF COVID-19

IN PARTICULAR PARENTS DECLARE:

- To be aware of the contagion containment measures in force at the present date
- To install and use the App. IMMUNI ( Immune) as it has been recommended in the on line meeting with The Scientific Technical Committee since 2<sup>nd</sup> July 2020
- To accept, in accordance with the Act n. 596, 13<sup>th</sup> August 2020 that the school staff measures the child's temperature and the temperature of the adult who enters the school accompanying him/her.
- That his/ her child, or other person in the same family unit, is not positive Covid -19, is not quarantined or has been verified positive Covid-19 and declared cured after two negative swabs.
- To undertake to keep their child at home in case of fever above 37.5°C or other symptoms (sore throat , cough, nasal congestion, conjunctivitis, loss of smell and taste) and to inform promptly his/her paediatrician and the school managers.
- To accept that, in case of discomfort, the child's temperature is measured with an infrared thermometer and that in case of temperature equal to 37,5°C or higher than 37,5 °C the school will accompany the child to a dedicated space until the arrival of the parents.
- To know that, in case of positivity, their child will not be able to be readmitted to school activities until he or she is fully recovered: this is certified according to the protocols provided.
- That they are aware that their child will have to comply with the health and hygiene regulations within the school.
- To have been adequately informed of all the health and hygiene dispositions in order to contain the spread of contagion of Covid-19.

- That they have been informed by the school of all the organizational and hygiene regulations for the safety and containment of the risk of spreading Covid-19 infection.
- To be aware that with the restart of all the interaction activities linked to the school activities, though with all the precautions, the risk of contagion can't be wiped completely out: the risk must be reduced to a minimum by means of the scrupulous and careful observance of rules . It is important to behave correctly and safely also outside school and school activities.
- To accept that entrances and exits are ruled (time and places) by the School and communicated to families
- To provide his/her child with a personal plastic bottle that can't be shared with other children. Children mustn't share plastic cups either.
- To remind their child not to leave any personal material and belongings at school.

In particular the School Manager declares:

- To have provided parents ( or legal tutors) with prompt information according to all organizational and sanitary devices and arrangements adopted to prevent the spread of the COVID-19 contagion and to communicate any changes or additions to the provisions
- That every member of the School staff has been adequately informed and trained. The Staff itself is committed to the scrupulous observance of every health requirement and will not go to work if symptoms of Covid-19 occur.
- That every member of the Staff is involved in the process of TRIAGE ( checking entry and exit, keeping the distance, sanitization, disinfection of furniture and hands).
- Not to promote any activity that encourages contacts of different groups of children ( even a few) during activities.
- To follow strongly and scrupulously, in case of clear infection Covid- 19 by children and adults attending the school, the hygiene and health rules given by the Health Authority.
- To have provided classrooms, toilets and other rooms in the school with special dispensers containing sanitizing hydroalcoholic or other active principles products provided that they are authorized by the Ministry of Health in order to guarantee the children's and the staff's hands hygiene.
- To set up every detail so that every child must be at least one meter far from another child or adult.
- To provide halls and corridors of the school with signals and warnings.
- In order to avoid gatherings, pupils must enter school at different staggered shifts.
- To provide the school with an entry and a different exit.

The signing of this agreement commits the parties to respect it in good faith . From a legal point of view, it does not release the parents signatories from any liability in the event of non-compliance with the regulations on the containment of the Covid-19 epidemic, the ordinary regulations on safety in the workplace and national guidelines.
